## About this **policy**

A **policy** is a set of rules that helps everyone know how things should be done.



This policy helps **government** schools stop racism.

It helps schools deal with racism and religious hate.

All Victorian government schools must use this policy.



This policy helps follow Victoria's [Child Safe Standards](#).

## Summary

All government schools in Victoria must:



Create a safe and welcoming place for everyone.



Work to stop racism.



Report racism to the Department.



Use the [Child Safe Standard 1](#) and [Child Safe Standard 5](#).

There are 3 main things all schools must do:


- Stop racism. Schools must be safe for everyone.



- Deal with racism. Schools must have clear systems to deal with racism.




- Report racism. Schools must report racism on eduSafe Plus.

## Victorian government schools do not tolerate racism



Racism harms young people's mental health and learning. I can make them feel like they do not belong.

## First Nations students

All government schools in Victoria must be safe and free of racism for First Nations students, families and communities.



This is what the [Child Safe Standard 1](#) says.




First Nations students, families and communities can experience racism in different ways.




First Nations students can have fewer chances in life if they cannot make their own choices or if we do not treat them fairly.

Racism can be made worse if we do not understand how things from the past can make people feel today. For example, taking First Nations children away from their families. This is called Stolen Generation.



Racism can make people feel left out and not safe in schools.



## Students who see and feel racism more often

First Nations students, students from African and Pasifika backgrounds and students from refugee backgrounds feel racism more often than others.



Jewish and Muslim students can feel **antisemitism** and **islamophobia**.

## Stop racism

Creating a safe and welcoming  
school




The [Child Safe Standard 1](#) says that schools must:

- Create a safe and welcoming space for First Nations students, families and communities.'
- Take steps to stop racism.
- Create and use helpful ways to deal with racism.



The [Child Safe Standard 5](#) says that schools must:

- Create spaces where all students feel safe and **respected**.
- Provide a safe and welcoming space for students from different backgrounds.

## How staff should stop and deal with racism safely

The [Child Safe Standard 5](#) says that schools must make sure that staff and volunteers understand what students need.

They must understand how to help students that need extra support.

Schools should offer training to all staff, for example, [Community Understanding and Safety Training](#).


## Cultural diversity and inclusion in teaching and learning

The Victorian Curriculum F-10 Version 2.0 helps to understand **cultural diversity and inclusion**.




**Cultural diversity** is when people from different cultures live together and respect each other's cultures.

**Inclusion** means that everyone feels like they belong.



All government schools in Victoria must teach [Intercultural Capability](#) and other programs. This includes [Aboriginal and Torres Strait Islander histories and cultures](#) and [Asia and Australia's engagement with Asia](#).



All secondary government schools in Victoria must teach [Holocaust Education](#), which is part of the [History Curriculum](#).



Schools must be careful about images they use. This is explained in the [Teaching and Learning Resources – Selecting Appropriate Materials](#) policy.

Schools must have learning materials that reflect their school community.

## Dealing with racism

The [Managing and Reporting School Incidents policy](#) says that schools must deal with racism.



Schools might need to help students who feel and see racism happening outside of school.

Schools should:



Tell the student or parent that the school believes them.



Think about how the student feels.



Find family or community members that the student trusts. This is very important for First Nations students.



Use teaching and [healing methods](#) to help fix the problems between the students, families, staff and communities.



Make sure that the students and their families or carers know how the school will deal with the situation.



Follow privacy rules.

## Report racism

## Report racism in eduSafe Plus or to the Incident Support and Operations Centre




The [Managing and Reporting School Incidents](#) policy says that schools must report racism and religious attacks in eduSafe Plus.



- The school should call the Incident Support and Operations Centre on 1800 126 126.



- Schools must tell everyone what was done about it.



- Privacy rules must be followed.

Tell you about the policy.



Tell you what to do if have felt or seen racism at school.





They can use this report to show what they are doing to make their school safer for all cultures and to stop racism.






